Thank you for your inquiry regarding residency at CSP Kehillah Housing. Kehillah Housing is a 15 unit not-for-profit apartment complex for the developmentally disabled located at 6000 SW Beaverton Hillsdale Hwy in Portland, Oregon.

Enclosed in this application packet are documents which contain relevant information regarding the application for residency and other necessary paperwork to be completed in order to apply for housing. All tenants must meet the HUD definition of developmentally disabled to be eligible for assistance. Verification from a health care professional will be required.

All pages of the application packet must be completed and signed. After receipt of these completed forms, your application will be reviewed. You will be notified of any deficiencies. All deficiencies must be corrected before the application can be processed for acceptance or denial.

CSP Kehillah Housing is a smoke free facility. Smoking is prohibited on the entire premises including but not limited to apartments, common areas, elevators, stairwells, landings, garden, sidewalks, and parking lots.

CSP Kehillah Housing offers rental assistance to those who qualify under regulations of the Section 811 Program of the United States Department of Housing and Urban Development. Everyone's rent is different based on their individual income.

Should your application be placed on a waiting list, we ask you to contact our office periodically as to your status of availability. We also ask you to notify us of any application changes so that we can keep your application information current.
